Further to your earlier conversation with Mr. Berangaut, please find attached the preliminary monetary authorities' accounts and two versions of the monetary survey for Russia. The monetary authorities' accounts and the first version of the monetary survey (in English) both cover the period from end-December 1991 through end-November 1992 and have been prepared by Fund staff (Attachments I and II, respectively). 1/ The second version of the monetary survey (in Russian) covering September 1992-November 1992 (Attachment III) has been prepared by the staff of the Central Bank of Russia (CBR), but the staff at this point is not fully acquainted with the methodology used.

Attachments I and II have three major shortcomings. First, the required data are not available for some items for recent dates. In this regard, the most recent information available on the Vneshekonombank (VEB) is for end-September 1992, some of the data on external assets and liabilities of the Government and the banking system date from June 30, 1992, and the balance sheet aggregates for Sberbank do not appear to have been updated for either end-September or end-October 1992. Second, the balance sheets of the banking system and the VEB are not fully informative in some cases, and the Fund staff finds it necessary to rely on data from off-balance sheet items. Third, the staff has not yet had the opportunity to discuss in detail with the staffs of the CBR and the VEB the treatment of various items in the balance sheet of the banking system, and with the VEB staff certain off-balance sheet items for the period since end-June 1992. These shortcomings affect particularly the following key areas: net foreign assets, credit and money.

The net foreign asset position will require further refinement in several areas. Only partial information is available on the stock of international reserves for end-October and end-November 1992, since the staff currently relies on off-balance sheet data as well as CBR data in this area. Another problem relates to the nonconvertible balances; the staff does not fully understand

the banking system accounts relating to payments to and from, settlements with, and credits to other states of the former U.S.S.R. Moreover, given the lack of data available to the staff, the estimated "other ruble balances" and "other net official foreign exchange" (held by the VEB) for end-October and end-November 1992 are based on the estimated amounts as of end-September 1992.

As regards credit, that portion which is made up of foreign exchange credit to resident entities (a large part extended by the VEB) for end-October and end-November 1992 has been preliminarily estimated on the basis of off-balance sheet data for the U.S. dollar balances at end-September, 1992, adjusted for exchange rate changes. The Fund staff also has questions regarding the use of credit created for the netting and liquidation of interenterprise arrears that were outstanding as of July 1, 1992, and whether such credit should be identified separately in domestic credit. Furthermore, updating of the Sberbank data would undoubtedly affect the credit aggregates.

The aggregate money figures for end-October and end-November include resident foreign exchange deposits of which a part (in the VEB) has been only provisionally estimated in the absence of any data from the VEB. Resident foreign exchange deposits in the VEB for end-October and end-November have been preliminarily estimated by adjusting the estimated end-September U.S. dollar amount for exchange rate changes in the meantime. Again, any updating of Sberbank data would also affect deposits and hence aggregate money.

My colleagues would be pleased to discuss these issues further with you, at your convenience. If you have any detailed questions, please contact Mr. Ross at 38973. One of the tasks of the forthcoming Article IV mission--at the technical level--will be to produce revised tables based on more complete data and discussions with officials at the CBR and the VEB.
